REACH OUT AND READ ADDS N.Y. JUDICIAL LAW CLERK, NONPROFIT PROGRAM DIRECTOR TO BOARD OF DIRECTORS

Nonprofit enhances diverse National Board of Directors with additions of Caleb B. King and Carly Roberts

NEW YORK CITY (Jan. 17, 2024) – Nonprofit <u>Reach Out and Read</u> has named Caleb B. King, judicial law clerk at the U.S. Courts of Appeals in New York, and Carly Roberts, Associate Program Director at the Overdeck Family Foundation, to its National Board of Directors. Baltimore pediatrician Dr. Ruby Dey also joined the board. Dr. Trude Haecker, Medical Director of Global Patient Services at Children's Hospital of Philadelphia, was named chair.
